You're a French taxpayer, a donation to the CMBV via the Cercle Rameau allow you to benefit from a tax reduction on the income tax (IRPP) up to 66% of the amount of the donation, up to a maximum of 20% of taxable income.

You can also benefit from a tax reduction on the French Property Tax (IFI) up to 75% of the amount of your donation, up to a maximum of €50.000 per year.

You're a company, a donation to the CMBV via the Cercle Rameau allow you to benefit from a tax reduction on the corporation tax up to 60% of the amount of the donation, up to a limit of 0.5% of turnover.
